

# Statement of Fees: School-based students

2023

An invoice will be issued to the base school for the students enrolled for fees whom it applies for, whereby payment will be strictly due within 14 days unless otherwise negotiated in writing to [accounts@brisbanesde.eq.edu.au](mailto:accounts@brisbanesde.eq.edu.au).

Upon enrolment for each student, you acknowledge your responsibilities to the following charges (as applicable):

- Enrolments received after 27 February 2023, will be invoiced on an individual basis as enrolment is received.
- Schools will be bulk-invoiced towards the end of Term 1 for students enrolled before 1 March 2022.
- Schools with unpaid fees from previous years will need to settle their account before new enrolments can be considered, and may be required to pay all fees upfront with future enrolments in the following years.
