

Statement of Fees: School-based students

2025

An invoice will be issued to the base school for the students enrolled for fees whom it applies for, whereby payment will be strictly due within 14 days unless otherwise negotiated in writing to accounts@brisbanesde.eq.edu.au.

Upon enrolment for each student, you acknowledge your responsibilities to the following charges (as applicable):

- Enrolments received after 21 February 2025, will be invoiced on an individual basis as enrolment is received.
- Schools will be bulk-invoiced towards the end of Term 1 for students enrolled before 1 March 2025.
- Schools with unpaid fees from previous years will need to settle their account before new enrolments can be considered, and may be required to pay all fees upfront with future enrolments in the following years.

Non-State Schools only (the following fee does not apply to Queensland State Schools)

Compulsory distance education fee

• This fee prescribed under the *Education (General Provisions) Regulation 2017* will increase annually with the Queensland Government indexation rate of 2.5%

 TRA eligibility for each student
- Half fees apply for enrolments commencing in Semester 2 (\$75.00); TRA is not claimed for these students

Queensland State Schools only

Textbook resource allowance (State schools only)

A general resource fee is not applicable for Queensland State School based enrolments (Years 7 to 12). As a result the TRA will be retained by Brisbane School of Distance Education.
